CERTIFICATE OF FIRST AMENDMENT TO AMENDED AND RESTATED DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR SUNRISE TERRITORY ESTATES

ADD: the following to Article VI, Section 2(I). <u>Association Accounting Responsibilities</u>, as follows:

"I. Accounting. Maintaining records of account of revenues and expenses in accordance with generally accepted accounting standards, filing tax returns, preparing annual financial statements and adhering to all applicable laws pertaining to outside review of the Association's financial records."
